Ms. Meg Subik would like the BOE to revisit Policy # 5300-E1 MCS Extra-Curricular Team Participant Agreement particularly this section below:

The Milford Central School District Board of Education recognizes that participation in athletic activities is a privilege not a right. Therefore, any student engaging in the use of tobacco, alcohol, illegal drugs, nonprescribed use of prescription medications or other intentional abuse of medications will be subject to the following consequences:

FIRST OFFENSE:

The student and their parent/guardians shall meet with the Athletic Director, coach(es) and/or the Principal/Superintendent. The meeting shall be scheduled to facilitate the attendance of parents/guardians; their attendance is required. The student shall be suspended from participation until the meeting occurs. The Principal/Superintendent shall conduct the meeting and provide an opportunity for all parties to provide information regarding the alleged conduct. The Principal/Superintendent shall make the final determination if a violation has occurred. If it is determined a violation has occurred, the student is suspended from participating in athletics for one full season. The Principal/Superintendent shall be responsible for determining the duration of the suspension and the suspension may overlap different athletic seasons depending on the timing of the violation. The student is required to participate in a substance abuse evaluation performed by an approved provider and complete all recommendations made as a result of the evaluation. Subsequent to the student completing all recommendations made as a result of the substance abuse evaluation, a meeting will be held with the student, parents and/or guardians, Athletic Director and coach before the student becomes eligible to participate in athletics.

Mr. Gerald Mertz stated the culture and feeling has changed since the new Regime has taken over specifically regarding student athletes being held to a different standard above and beyond other students.
